An Update on the Tax and Budget System

AACF is closely following several important pieces of tax and budget legislation that impact low-families now that the Arkansas State Legislature and the U.S. Congress have reconvened, As we move forward, it's more important than ever to advocate for tax policies and spending measures that lift our low-income families out of poverty. They are hit hard by the economic downturn. This update includes a summary of three important pieces of federal legislation: the State Children's Health Insurance Program (SCHIP), the Child Tax Credit, and the Economic Recovery Package.

# Federal Tax and Budget update

# **State Child Health Insurance Program**

By a vote of 289-139, the U.S. House of Representatives voted to reauthorize the Child Health Insurance Program Reauthorization Act known as the State Children's Health Insurance Program (SCHIP) (H.R. 2) on Wednesday. The Senate is moving quickly and there is a strong indication that a final bill will be ready for the new President to sign in late January.

SCHIP reauthorization is critical to Arkansas's efforts to maintain the health and economic stability of families through the successful ARKids First program. Without passage, Arkansas will not be able to continue to serve many children currently enrolled.

We would like to thank Reps. Marion Berry and Mike Ross for voting for this critical legislation. Passing the House was only the first legislative hurdle. We will follow the bill closely as it moves through the Senate and may ask you to weigh in by calling our Congressional members to encourage the continued support of this legislation. #### **Child Tax Credit**

In the last Congress, the earnings threshold for the child tax credit was reduced from \$12,050 to \$8,500 for tax year 2008. This reduction was temporary. To make the reduction permanent, Sen. Blanche Lincoln recently introduced the Working Family Child Assistance Act (S. 26). It will

help 33,677 Arkansas children who otherwise wouldn't be eligible and will provide an increased tax benefit to an additional 116,657 Arkansas children because the size of the credit is based on the amount by which the family's earnings exceed the threshold. Please let Senator Lincoln know that we appreciate her continued support of working families in Arkansas!

The child tax credit is also an effective stimulus for the economy.

# The Economic Recovery Package

Congress will soon consider a comprehensive economic recovery package designed to stimulate our national economy. Although legislation has not been filed, Democrats in the U.S. House of Representatives just released its proposal this week. The House proposal provides funding for many important low-income related programs, including: the Child Care and Development Block Grant, Head Start, and the Supplemental Nutrition Assistance Program.

AACF urges Congress to adopt well-designed policies that help low-income families and provide a meaningful boost to the economy by preserving and restoring jobs.
